I am pleased to announce the 2024 PennDOT/NECEPT Asphalt Technician Certification Program. In response to the FHWA mandate that states establish programs to have qualified concrete, aggregate and asphalt technicians working on federally funded construction projects, PennDOT partnered with the Northeast Center of Excellence for Pavement Technology (NECEPT) at The Thomas D. Larson Pennsylvania Transportation Institute, The Pennsylvania State University to administer and conduct Asphalt Technician Certification courses in a consistent and up-to-date manner on an annual basis.

#### **Schedule:**

All courses will be held on various dates starting in January 2024 and ending in April 2024. Exam retest dates are scheduled in April and May 2024. Most courses and course lectures will be held virtually, but there are two in-person courses scheduled for the Asphalt Field Technician Review and Certification Course and one in-person course scheduled for the Asphalt Level 1 Plant Technician Review & Certification Course. In addition, all the Superpave Volumetric Mix Design Workshops will be held in-person.

Virtual courses will be offered using the Zoom platform. PennDOT employees are to open the Zoom courses by clicking the Join Zoom Meeting link provided by NECEPT and then clicking the Launch Meeting button and then clicking the Join from Your Browser link. The virtual courses will have online exams. For online exams, a desktop or laptop computer <u>must</u> be used,

and applicant's computer or laptop must be equipped with a working camera/webcam for NECEPT to confirm the identity of the individual taking the online exam. Using an iPad, iPhone, or similar device will cause issues in taking the online exams and they are not recommended. In-person courses will have in-person exams. In-person courses may be changed to virtual (online) courses or canceled due to possible restrictions imposed by future Federal, State, or University safety guidelines regarding COVID-19 or due to low registration enrollment.

# PennDOT Employee Course and Certification Registration Process:

The following process is to be followed for each proposed attendee:

- 1. An Out Service Training (OST) Request is <u>NOT</u> required for the 2024 Asphalt Technician Certification Courses, Card Only Registrations (Level 2 Plant Technician Initial Certifications and Certification Renewals Using Option A Learning Activities), or Exam Retests.
- 2. To be <u>officially registered</u> for a course, card only registration, or exam retest, a participant must:
  - Complete the online registration at <a href="http://www.superpave.psu.edu/">http://www.superpave.psu.edu/</a> (under the menu item for "Training") as instructed in the above hyperlinked 2024 Asphalt Technician Certification Packets. Hardcopy course application forms will not be accepted by NECEPT.
  - All PennDOT employee course registrations (online registrations) are <u>strongly encouraged</u> to be submitted to NECEPT <u>by November 22, 2023 (day before the Thanksgiving Day Holiday)</u>, but ultimately, all course registrations <u>MUST</u> be submitted to NECEPT no later than 15 <u>business</u> days before the course start date.
- 3. Upon receiving the course registration confirmation email from NECEPT that the individual is officially registered for a specific course and course date, certification card only registration, or exam retest, the confirmation email <u>MUST</u> be forwarded to the Bureau/District Training Coordinator along with a request for enrollment in Success Factors for the specific course and course date. Enrollment in Success Factors is <u>NOT</u> required for certification card only registrations or exam retest registrations. The enrollment request may require completion of the *Highway Admin Training Enrollment Form* (Central Office employees). Registration confirmation emails are sent immediately upon the registration being successfully completed and submitted in NECEPT's online registration system.
- 4. After receiving a PennDOT employee's course registration confirmation email and a Success Factors enrollment request, the Bureau/District Training Coordinator will enroll each PennDOT employee in Success Factors for the appropriate course and course date. Enrollment in Success Factors must occur before the course start date. Success Factors enrollment is <u>NOT</u> required for certification card only type registrations (Level 2 Plant Technician Initial Certifications and Certification Renewals Using Option A Learning Activities), or for Exam Retests. The Success Factors Course Codes are as shown in the table below.

- 5. The roster in Success Factors will be used to verify and approve payment of invoices received from NECEPT for each course, course date, and course attendee.
- 6. Travel arrangements, including lodging (if necessary), will also be coordinated at the Bureau/District level. The travel policy, as it relates to group bookings, does not apply to these NECEPT asphalt technician certification courses.

Please note, PennDOT applicants are not required to submit payment at the time of online registration. NECEPT will direct bill each District/Bureau for the PennDOT attendees that completed the training. NECEPT invoices are to be paid at the District/Bureau level.
